Contest Rules

1. Club Med Canada launches *Contest Club Med x Rossignol 2017-2018* which runs from September 20, 2017 to March 25, 2018.

CONTEST DURATION

Public launch of contest: September 20th, 2017, 9am EST

Contest launch: September 20th, 2017, 9am EST

Ending contest: March 25th, 2018, 11.59pm EST

Draw date: March 26th, 2018, 10am EST

ELIGIBILITY

2. This contest is open to residents of Canada aged 18 or older, except for employees, agents and representatives of Club Med and Rossignol and their affiliates and advertising and promotional agencies, the suppliers of the prize(s), materials and services related to the current contest, as well as members of their immediate families (brothers, sisters, children, father, mother), their legal or de facto spouses and all persons with whom said employees, agents and representatives are domiciled.

HOW TO ENTER

No purchase required.

3. The contest is exclusive to Club Med and Rossignol. To participate, the participant will go on a dedicated website <http://clubmed-concours-contest.ca/rossignol/en/contest/>. The participant will give its gender, first name, last name, email address and answers a simple question.

The contest will be presented to Club Med Canada and Rossignol Canada websites, and on their respective Facebook pages. The contest will be also presented to ski resorts participating to demo days.

The contest is open to residents of Canada who are 18 years of age or older. No purchase necessary. Limit of one (1) entry per person and email address. Only one (1) email address can be used to enter the contest, regardless of the number of addresses held by the participant. The usage of different names, identities and/or email addresses will automatically result in disqualification.

PRIZE

4. The prize consists of 7 nights for 2 adults of 18 years old and more for the following Club Med Resorts: Peisey-Vallandry, La Plagne 2100, Valmorel and Avoriaz. Availability is subject to capacity restrictions.
